### Abstract

Situated approximately 12 kilometres from the South Sudan border and 30 kilometres from the Congo border, Bidi Bidi emerges as a microcosm of resilience amid the challenges of sporadic violence and tribal conflicts. This paper aims to illuminate the transformative potentialembedded within gender-equality education exemplified by the YTT Gender-Prevention Equality/GBV program. Beyond the scope of addressing Gender-Equality and GBV, this program empowers women and children, thereby forging new narratives within the multifaceted canvas of this refugee settlement.

Bidi Bidi Refugee Settlement, sprawling over 250 square kilometres within Uganda's North-Western region in the Yumbe District, transcends its geographic boundaries to embody the narratives of more than 270,000 refugees. These peoples, driven by the horrors of civil war, poverty, and violence, have sought refuge within Bidi Bidi. The settlement's strategic proximity to both the Congo border (DRC) and the South Sudan border presents a dual reality—offering sanctuary while simultaneously exposing its inhabitants to the echoes of neighbouring unrest, sporadic violence, and tribal conflicts. This paper embarks on an exploration of gender-equality education's influence, as it fosters resilience, empowerment, and GBV prevention within the intricate tapestry of Bidi Bidi.

Divided into five distinct zones Bidibidi, Swinga, Yoyo, Abrimajo and Annex, and Ariwa—each zone carries its unique significance, a microcosm of unity amidst diversity. Bidibidi, previously a humble village, transformed into a sanctuary in August 2016, when it was designated as a refugee settlement. The metamorphosis of a vacant arid patch near Yumbe into a home for approximately 270,000 refugees underscores the power of humanity's collective response to displacement and adversity.

The transformation of Bidi Bidi from a village to a refugee settlement was a purposeful endeavour by the Ugandan government. It represented a departure from the conventional camp approach to a holistic settlement concept.
